STARRED QUESTIONS AND ANSWERS.

REALIZATION OF MINING CESS IN SINGHBHUM.

- *222. Shri SIDIU HEMBROM: Will the Hon'ble Minister in charge of the Revenue Department be pleased to state—
- (a) whether it is a fact that mining royalty and mining cess are not realised by certain lease-holders of mines in the district of Singhbhum;
- (b) if the answer to clause (a) be in the affirmative, whether the State Government propose to enquire and lay on the table a list of the mines of lease-holders who have not yet paid up the royalty and cess charges;
- (c) whether it is a fact that Dwarika Das Agarwala and Ram Gopal Pasari, who are also lease-holders of mines, have not paid the royalty and cess dues for a number of years;
- (d) if the answer to clause (c) be in the affirmative, whether Government propose to take steps to realise the dues, if not, why?
- The Hon'ble Shri KRISHNA BALLABH SAHAY: (a) The answer is in the negative. Royalties and rent are realised half-yearly on due dates in every April and October.
- (b) A list of outstanding dues from various lessees is placed on the table. The Deputy Commissioner, Singhbhum, has been instructed to take immediate action for the realisation of the Government dues.

CO-OPERATIVE ORGANISATION.

*116. Shri RAMASIS THAKUR: Will the Hon'ble Minister in charge of the Finance Department be pleased to state—

(a) whether it is the policy of Government to give preference to Co-operative Organisations in the matter of appointment of stockists of foodgrains;

(b) if so, have Government received reports of violation of the said policy from the Sitamarhi Central Co-operative Union, etc.;

(c) if the answers to clauses (a) and (b) be in the affirmative, do Government propose to set aside the appointment of non-operative stockists or reduce their quota, and direct the officers concerned to appoint the Sitamarhi Central Co-operative Union as stockists at places where they can arrange for suitable godowns in their areas of operation?

The Hon'ble Dr. ANUGRAH NARAYAN SINHA: (a) It is the policy of Government to give preference to Co-operative Organisation in the wholesale and retail distribution of Government foodgrains. Though the work of storage has not been specifically mentioned in the Government instructions this is also included in the part of the process of distribution.

- (b) Request for appointment was received from the Sitamarhi Central Co-operative Union which was sent to the District Magistrate of Muzaffarpur for giving stockistship to the Union on the fulfilment of conditions applicable to the stockist and if they have suitable godown.
- (c) In view of the reply to clause (b) above this question does not arise.
