STARRED QUESTIONS AND ANSWERS.

REALIZATION OF MINING CESS IN SINGHBHUM.

- *222. Shri SIDIU HEMBROM: Will the Hon'ble Minister in charge of the Revenue Department be pleased to state—
- (a) whether it is a fact that mining royalty and mining cess are not realised by certain lease-holders of mines in the district of Singhbhum;
- (b) if the answer to clause (a) be in the affirmative, whether the State Government propose to enquire and lay on the table a list of the mines of lease-holders who have not yet paid up the royalty and cess charges;
- (c) whether it is a fact that Dwarika Das Agarwala and Ram Gopal Pasari, who are also lease-holders of mines, have not paid the royalty and cess dues for a number of years;
- (d) if the answer to clause (c) be in the affirmative, whether Government propose to take steps to realise the dues, if not, why?
- The Hon'ble Shri KRISHNA BALLABH SAHAY: (a) The answer is in the negative. Royalties and rent are realised half-yearly on due dates in every April and October.
- (b) A list of outstanding dues from various lessees is placed on the table. The Deputy Commissioner, Singhbhum, has been instructed to take immediate action for the realisation of the Government dues.

माननीय डा॰ अनुग्रह नारायण सिह—(क) बिहार ऐग्रीकलचरिस्ट लेभी आईर तथा उसके सम्बन्ध में सरकारी आज्ञानुसार किसानों को अन्न हस्तान्तरण करने के बाद ही परचेंजिंग एजेंन्टों को चाहिए कि कुल मूल्य चुकती दे दे। सरकार को इस बात की बिलकुल जानकारी नहीं है कि किसी खास परचेंजिंग एजेन्ट ने किसानों से माल प्राप्त करके भी उसका मूल्य नहीं चुकाया है।

(ख) मंजप्रतरपुर के जिलाधीश को कहा जा चुका है कि वे इस विषय में जांच करके जिन लोगों की मूल्य नहीं चुकाया गया हो उन लोगों को कम-से-कम समय में मूल्य चुकाने की व्यवस्था करें और इस विषय में सरकार के पास पूरी रिपोर्ट भेजें।

श्री रामाशीष ठाकुर—(क) के उत्तर में कहा गया है कि सरकार की जानकारी नहीं है कि कीमत मिली है या नहीं। इस प्रश्न के पूछे जाने के बाद क्या सरकार ने सीतामढ़ी के एस॰ डी॰ खो॰ या मुजफ्फरपुर के कलक्टर से इसके बारे में दिखापत किया हैं?

माननीय डा॰ अनुग्रह नारायण सिंह—सरकार ने जबाव में कहा है कि कलक्टर को आदेश दिया गया है कि अगर किसी को कीमत नहीं मिली है तो उसकी जल्द-सै-जल्द चुकती कर दें।

श्री रामाशीय ठाकुर क्या माननीय मंत्री मुझसे सूचना लेंगे कि सीतामढ़ी के लागी से जो पिंछले साल धान लिया गया था उसकी कीमत अभी तक चुकती नहीं की गई है।

SALES TAX ON BOOKS.

*288. Shri RAMASIS THAKUR: Will the Hon'ble Minister in charge of the Finance Department be pleased to state—

- (a) whether attention of Government has been drawn to a news published in a local English Daily, dated the 19th August, 1951, under the caption "Sales Tax on books" wherein it has been stated that a largely attended meeting of the Publishers and Booksellers of Bihar was held on August 16 in the premises of Ajanta Press, Ltd., Patna, to devise means to approach the Government to exempt books from the schedule of Sales Tax;
- (b) whether attention of Government has also been drawn to a leading editorial note published in a local Hindi Daily, dated the 22nd August 1951, under the caption "PUSTAKON PAR BIKRI KAR" wherein a strong case has been made out for exemption of books from the schedule of Sales Tax;
- (c) if the answers to clauses (a) and (b) be in the affirmative, what steps have Government proposed to take to fulfil the above mentioned demand of the Publishers and Booksellers ?

*240. Shri RAJKISHORE SINGH: Will the Hon'ble Minister in charge of the Finance Department be pleased to state—

- (a) whether the Pay Revision Committee recommended for the uniform pay of all Engineers of same qualifications serving either in District Board or in P. W. D.;
- (b) if the answer to clause (a) be in the negative whether Government are aware that there is a great discontentment among the Engineers of the District Board; if so, whether Government propose to introduce a standard pay for all Engineers in all Departments of the State Government?

The Hon'ble Dr. ANUGRAH NARAYAN SINHA: (a) Vide reply to clause (c) of question no. 239 above.

(b) The question does not arise. The recommendation of the Pay Revision Committee in this respect along with other relevant letails is still under examination of Government.
