STARRED QUESTIONS AND ANSWERS.

PROVISION OF EMPLOYMENT TO THE LANDLESS LABOURERS.

***266. Shri HARINATH MISRA :** Will the Hon'ble the Minister in charge of the Labour Department be pleased to state—

(a) whether the attention of Government has been drawn towards a news item published in an English Daily, among other things, that a scheme for providing employment to landless labourers had been put into operation in the State;

(b) if the answer to clause (a) be in the affirmative, the main points of the schemes which have been put into operation, the number of landless labourers districtwise who have been benefited or are likely to be benefited by the scheme?

The Hon'ble Shri KRISHNA BALLABH SAHAY : (a) and (b) In the absence of the date of publication of the English Daily, it has not been possible to refer to the news item but a scheme for combating unemployment among the landless labourers was drawn up by Government and the same was circulated to all the District Officers in Revenue Department letter no. 1226-R., dated the 14th November 1950, a copy of which is laid on the table. It is not possible at this stage to indicate the number of landless labourers districtwise who have been benefited or are likely to be benefited by the scheme.

*२८५। श्री जगन्नाथ सिंह—क्या माननीय मंत्री, सिंचाई विभाग, यह बताने को कृपा करेंगे कि—

(क) क्या यह बात सही है कि ससराम थाने में फजलगंज के पास नहर में, सैफन, बनाने की योजना बहुत दिनों से विचाराधीन है;

(ख) क्या यह सच है कि उक्त योजना को कार्यान्वित करने की सफाई नहर विभाग के स्थानीय अधिकारियों ने की है;

(ग) यदि खंड (क) और (ख) का उत्तर स्वोकारात्मक है, तो इस उपयोगी योजना को शीघ्र पूरा करने के लिये सरकार क्या करने जा रही है?

माननीय श्री रामचरित्र सिंह—(क) उत्तर स्वोकारात्मक है।

(ख) उत्तर स्वोकारात्मक है।

(ग) यह योजना टेक्निकल एक्सपर्ट्स के विचाराधीन है और पॉसिबल होने पर कार्यान्वित किया जायगा।

श्री जगन्नाथ सिंह—उस योजना को कार्यान्वित करने की सफाई स्थानीय अधिकारियों ने की थी या नहीं, और की थी तो कब की थी, मैं जानना चाहता हूँ?

माननीय श्री रामचरित्र सिंह—सेवाल से साफ मालूम होता है कि यह योजना टेक्निकल एक्सपर्ट्स के विचाराधीन है और हो सकता है कि एक एक्सपर्ट से दूसरे एक्सपर्ट के पास जांच-पड़ताल के लिए गये हों।

श्री शिवनन्दन राम—सरकार के पास अभी कितनी स्कीम विचाराधीन हैं?

माननीय अध्यक्ष—यह प्रश्न नहीं उठता है।

माननीय श्री रामचरित्र सिंह—मैं इसका उत्तर दे देना चाहता हूँ?

श्री प्रभुनाथ सिंह—

If the Supplementary question has been ruled out by the Chair, the Hon'ble Minister need not reply to it.

CHANNEL BETWEEN RIVER KAO AND GADEHIGHAT.

*286. Shri JAGANNATH SINHA: Will the Hon'ble Irrigation Minister be pleased to state—

(a) whether it is a fact that the project of cutting a channel from the river Kao to Gadehighat in the Sasaram P.S. is under the investigation of the department since long;

(b) if answer to clause (a) is in the affirmative, what progress has so far been made and what are the reasons of delay in completing the investigation?

माननाय श्री रामचरित्र सिंह—

(a) and (b) The answer is in the affirmative. In this connection attention of the hon'ble member is invited to the answer furnished to the Question no. 6 of the last Budget Session, a copy of which is laid on the library table. The scheme has been re-investigated and it has not yet been found to be feasible. The question of delay in completing the investigation, therefore does not arise.

Shri JAGANNATH SINGH : I want to know on what grounds this scheme has been found to be not feasible?

The Hon'ble Shri RAMCHARITRA SINGH :

PROGRESS IN DAMODAR VALLEY PROJECT.

*287. **Shri JAGANNATH SINGH :** Will the Hon'ble Irrigation Minister be pleased to state—

(a) the progress so far made in the construction of dams and generation of electricity from the Damodar Valley Project;

(b) whether it is a fact that the estimated cost of expenditure over the said scheme has very much increased;

(c) whether there is any proposal to shift the headquarters of the Corporation to Bihar with a view to increasing greater efficiency and supervision;

(d) whether it is a fact that suitable land and adequate compensation have not been settled for the local inhabitants who are to be uprooted from their hearth and home and re-settled elsewhere?

The Hon'ble Shri RAMCHARITRA SINGH : (a) A copy of the latest Damodar Valley Corporation Progress Report for the period ending 15th December is placed on the table of the library. Briefly the progress on the major works is —

Tilaya Dam.—The preliminary works consisting of service roads, quarters, offices, worksheds, etc., have all been completed.

The foundation excavation of the dam is in progress and cement concrete work in the foundation has been started;
