***९१। श्री बाबूलाल टुड्डू--क्या मंत्री, शिक्षा-विभाग, यह बता**ने की कृपा करेंगे कि---

- (क) क्या यह बात सही है कि जिला संयाल परगना के थाना बड़दीत, ग्राम बड़-दीत में लड़कियों के लिये मिड्ल स्कूल का मकान बनाया जा रहा है और उस स्कूल बिल्डिंग का ठीकेदार श्री हिरदान दे भगत है;
- (ख) क्या यह बात सही है कि १९५१ के मार्च महोने से मकान बनाया जा रहा है;
- (ग) यदि खंड (क) और (ख) के उत्तर स्वीकारात्मक हैं, तो मकाने कातक बनेगा ?

श्री बदरीनाथ वर्म्मा—(क) जी हां, यह बात सही है कि ग्राम बड़दीत में लड़िकयों

Shri HARINATH MISRA: (a) There is no such rule or practice requiring transfer of officers from one place or post to another, unless it becomes necessary in the interest of public service or the officer is found unsuitable for a particular post.

- (b) The answer to the first part of the question is in the affirmative and to the second part in the negative.
 - (c) Does not arise.

ISSUE OF FOODGRAINS TO A MINOR RATION STOKIST.

- *103. Shri NAND KISHORE NARAIN: Will the Minister incharge of Supply and Price Control Department be pleased to state—
- (a) whether it is a fact that huge stock of foodgrains worth ruppes four to five lacs has been issued from Government godowns of Patna for many years against foodgrains licence issued in the name of a boy of about 2 or 3 years of Patna City to save him from legal action even when he indulges in blackmarketing;
- (b) whether it is a fact that the present (1) Office Superintendent Mr. Alley Navi, (2) S. S. Mr. Bimal Pd. and (3) A. R. O. Mr. Nawal Kishore who were mainly responsible for the issue of the licence have enjoyed private shares of income from that ration shop;
- (c) if the answer to clause (b) be in the negative, the names of officers responsible for the issue of that licence;
- (d) the name of the Inspector, if any, who submitted report against that licensee and the action taken thereon?

Shri HARINATH MISRA: (a) Stocks from retail sale by the ration shop keeper was issued to him from Government stock regularly according to the periodical indents submitted by him, as checked and passed by the Section Superintendent concerned. It is not possible to determine the money value of such issues made from the year 1944. The fact that the ration shop keeper was a minor was not known to the rationing authority as licences used formerly to be issued from the District Magistrate's office. When it was brought to the notice of the rationing authorities, his licence was cancelled and the ration shop taken away from him.

(b) The answer is in the negative.

- (c) It is not possible to furnish the name of the officer who issued the licence from District Magistrate's office in the year 1944.
- (d) Shri N. N. Tripathi was the Inspector, who submitted report against the licensee on 3rd November, 1951. The ration shop and foodgrains licence were cancelled and entire security deposit was forfeited.

RE-ALLOTMENT 111 OF RATION SHOP TO THE MINOR INSPITE OF THE REPORT OF RATIONING INSPECTOR.

- (a) whether it is a fact that in the order cancelling the licence, it was mentioned that the licensee being a minor no action could be taken against him and the action was therefore taken against his father with strong stricture against him;
- (b) whether it is a fact that again through the manouvring of interested office Superintendent and S.S. the shop was provisionally resillected that he same man, the minor's father;
- (c) whether it is a fact that the Inspector who submitted report against the "said licensee is being indirectly harassed by the said interested officers?".

Shri HARINATH MISRA: (a) The answer is in the negative.

Shri HARINATH MISRA: He was granted a licence in 1944 under the British Raj not Congress Raj and he continued to have the licence till 1951 when the matter was detected and the licence was cancelled.

Shri SRISH CHANDRA BANERJEE: What action was taken against the official for not keeping this information?
