HOLIDAYS FOR MIDDLE AND PRIMARY SCHOOLS.

237. Rai BRIJ RAJ KRISHNA: (a) Will Government be pleased to state if it is a fact that in September 1926 Government in the Ministry of Education issued a list of holidays for middle and primary schools?

- (b) Will Government be pleased to lay on the table a statement showing (i) the total number of public holidays (including those under the Negotiable Instruments Act, 1881, and those announced by Executive Orders; (ii) the number of holidays provided in the list referred to in clause (a) above, for the following Muhammadan festivals—Shabebarat, Id-ul-fitr Id-uz-Zoha, Muharram, Chehlum and Fatiha Dawaz-dahum; (iii) and the number of holidays provided in the list referred to in clause (a) for the following Hindu festivals—Basant Panchami, Shivaratri, Holi, Diwali, Dawat-Puja, Chaitra Shankranti, Ganga Dasahara, Janamashtmi, Chatth, Ram Navami and Mahalaya?
 - (c) Is it a fact that while Ganga Dasahana, Janamashtmi, Chatth, Ram Navami and Mahalaya are public holidays under the Negotiable Instruments Act, they are not mentioned at all in the list of holidays issued for middle and primary schools? Is it

their University marks.
