CONSTRUCTION OF ROAD FROM DALTONGANJ TO BHANDARIES.

- †\*977. Shri JITU RAM: Will the Hon'ble the Minister in charge of the Public Works Department be pleased to state—
- (a) whether there is any proposal before Government for constructing a road from Daltonganj to Bhandaries via Ramgarh and Ramkaunda;
- (b) if the answer to clause (a) be in the affirmative, whether Government propose to start the work at once?

The Hon'ble Shri ABDUL QUAIYUM ANSARI: (a) The reply is in the negative.

(b) The question does not arise.

- (b) what was the total number of subscribers of the above weekly paper on the 1st March, 1951 who had paid the annual subscription money in advance and whose subscription period remained unexpired on the 1st March, 1951;
- (c) the number of copies of the said weekly distributed free of cost to Adibasis?

The Hon'ble Shri BADRINATH VERMA: (a) 3,000 copies every

week.

(b) The journal is intended mainly for free distribution amongst Adibasis. It is open to any one to subscribe to it on payment of Rs. 1/8 annually. The number of such subscribers on 1st March, 1951 was 32 only.

(c) The number of copies of the said weekly distributed free of

cost to Adibasis is 2,000 approximately.

### THE EDITOR OF THE "ADIBASI".

†\*999. Shri IGNACE BECK: Will the Hon'ble Minister in charge of the Public Relations Department be pleased to state—

- (a) whether any advertisement calling for applications for the post of the editor of the "Adibasi", which is published by the Public Relations Department, was issued before or after the appointment of the present editor of that paper;
- (b) what are the educational qualifications of the present editor of that paper;

(c) whether he has passed any examination of any university;

(d) whether he had any experience gained by working in the editorial department of any newspaper before being appointed as editor of the "Adibasi"?

The Hon'ble Shri BADRINATH VERMA: (a) The answer is

in the negative.

(b) He was sub-editor of 'Mahavir', Patna, for one year; on the editorial board of 'Maya' (Allahabad) for three years; Sub-editor of 'Hans' and Editor of 'Kahani' of Banaras for four years.

(c) The answer is in the negative.

(d) Yes, he had several years' experience of journalism before he was appointed.

## RADIO SET OF THE LORSEVI BABBAN LIBRARY.

(a) whether it is a fact that the radio set of the Loksevi Babban Library was deposited with the Maintenance Engineer of the Publicity Department for repairs on 27th May, 1950;

- (b) whether it is a fact that after a lapse of over six months the radio was at long last repaired and made over to the President of the said Library committee and a sum of Rs. 15-10-0 (Rupees fifteen and ten annas) only was paid on 11th December, 1950 as the cost of the repairs:
- (c) whether it is a fact that the acknowledgement receipt for the above sum of fifteen rupees ten annas was not granted at the time but in the circumstances of the case promised to be sent in due course;
- (d) whether it is a fact that the receipt has not yet been sent in spite of repeated reminders therefor in writing and orally?

The Hon'ble Shri BADRINATH VERMA: (a) The radio set was received in the Maintenance section on 30th May, 1950.

- (b) The parts of the radio were neither available locally nor from Calcutta firm and as such it could not be repaired and made over to the President earlier. It was repaired and made over to the President on 11th December, 1950 after payment of Rs. 15/10 towards the cost of parts supplied to the radio sets.
- (c) The necessary entry of Rs. 15-10-0 was made in cash book on 11th December 1950. As no receipt book was available, the receipt could not be given on the very day.
  - (d) The receipt has been sent. The question does not arise.

Shri JAGANNATH SINGH: I want to know why spare parts are not kept for mechanic service?

The Hon'ble Shri BADRINATH VERMA: They are kept but sometimes they exhaust and so they are not available.
