## STARRED QUESTIONS AND ANSWERS

बिहार के कोटे का कपड़ा लेने के लिये एजेण्ट ।

A\*५१। श्री जयनारायण 'विनीत'—क्या माननीय मंत्री, पूर्ति एवं मूल्य नियंत्रण विभाग, यह बताने की कृपा करेंगे कि—

(क) क्या बिहार के लिये मिलों से बिहार के कोटे के कपड़े लेने के लिये कोई एजेण्ट हैं ;

(ख) यदि खंड (क) का उत्तर 'हां' है तो क्या वे केन्द्रीय क्लॉथ कंट्रोलर के समक्ष बिहार में खपने वाले कपड़ों का ठीक-ठीक चित्रण कर बिहार के लिये अधिक से अधिक पोपुलर कपड़े लेने का यत्न करते हैं ;

(ग) क्या तथाकथित एजेण्ट साहब बिहारी हैं ;

(घ) उक्त एजेण्ट की नियुक्ति के नियम (क्राटेरीअन) क्या-क्या रखे गये हैं ?

श्री वीरचन्द्र पटेल—(क) उत्तर 'ना' है ।

(ख), (ग) और (घ) प्रश्न नहीं उठता है ।

श्री जयनारायण 'विनीत'—अगर कोई एजेण्ट नहीं है तो बिहार का कोटा कैसे आता है ?

श्री वीरचन्द्र पटेल—जितने इम्पोर्ट्स हैं, उनका अपना-अपना कमीशन एजेण्ट्स, बम्बई और अहमदाबाद में रहते हैं। उन एजेण्टों को ऑर्डर देकर वहां से कपड़े मंगाये जाते हैं। गवर्नमेंट के तरफ से टेक्स्टाइल कमिश्नर के पास फीगर्स चले जाते हैं कि किस इम्पोर्टर को कितना एलोट हुआ है। गवर्नमेंट के तरफ से कोई एजेण्ट बम्बई और अहमदाबाद में नहीं है ।

**The Hon'ble Shri RAMCHARITRA SINGH :** Sir, I beg to move :

**The Hon'ble the Shri RAMCHARITRA SINGH :** Sir, I beg to move :

APPOINTMENT OF 120 SUB-DEPUTY MAGISTRATES AND RE-EMPLOYMENT OF RETIRED DEPUTY MAGISTRATES.

**Shri MUHAMMAD ABDUL GHANI :** Sir, I beg to move :

That the provision of Rs. 1,33,512 for "District Administration—General Establishment—Pay of Officers—Voted" be reduced by Re. 1.

काफी है कि १२० सब-डिप्टी मैजिस्ट्रेटों के लिये काम खोजा जा रहा है और कुछ रिटायरमेंटों के लिये भी काम खोजा जा रहा है, उनके लिये भी आप सर्च मांगते हैं। यह अफसरान किन्-किन् जिलों में काम कर रहे हैं और इनके जिम्मे क्या-क्या काम है, यह हम जानना चाहते हैं।

**The Hon'ble Shri RAMCHARITRA SINGH :** Sir, there are 120 Sub-Deputy Magistrates and some Deputy Magistrates but the details as to where they are posted and what work they are doing, are very difficult to give off-hand. I require some time to collect all these informations. I think if the hon'ble member wants all such detailed informations, he should put a question to that effect.

**The Hon'ble the SPEAKER :** But that has been mentioned in the cut-motion by the Hon'ble Member. The cut-motion is meant to discuss the justification, the details of 120 Sub-Deputy Magistrates, the re-employment of retired Deputy Magistrates, their postings and the work entrusted to them.

**The Hon'ble Shri RAMCHARITRA SINGH :** But the collection of all these informations will take some time. The cut-motion was received in the department only about two days ago. I must impress upon the House that Government must give correct informations.

**The Hon'ble the SPEAKER :** But papers regarding such details must be available in the Secretariat.

**The Hon'ble Shri RAMCHARITRA SINGH :** All these papers cannot be available in one place. They might be available in several places and some papers might not be available in the Secretariat.

**The Hon'ble the SPEAKER :** Government must have these particulars ready. However, to accommodate the Hon'ble Minister, I will take up this demand tomorrow.

**The Hon'ble Shri RAMCHARITRA SINGH :** I have explained the position. If the hon'ble member wants all these informations, he should put in a question.

**\*Shri RAMESHWAR PRASAD SINGH :** Sir, so far as this demand is concerned, you will find at page 12 of the first Supplementary Statement of Expenditure for 1951-52, that item (c) speaks of re-employment of some Deputy Collectors. The number of the Deputy Collectors is not given there. You ask us to vote for grant but you do not give the number. I am much surprised to see a demand like this without giving details or the number of Deputy Magistrates.
