### CONDOLENCES.

CONDOLENCE ON THE DEATHS OF MESSES. ZAMID BUSSAIN AND HARI KISHORE PRASAD, BABU BRAJKISHORE PRASAD AND PANDIT MADAN MOHAN MALVIVA.

The Hon'ble the SPEAKER: It is now my painful duty to refer to the heavy loss that the province has sustained by the sad demise of two of our colleagues since we met last, namely, Mr. Zahid Hussian and Mr. Hari Kishore Prasad. Mr. Zahid Hussian was a member of the Sitamarhi Bar where he had a flourishing practice. He was elected a member of this Assembly on the Muslim League ticket last year from the Sitamarhi Muhammadan Rural Constituency. He died of heart failure in the afternoon of the 9th September last in the Sitamarhi Court. He was associated with various committees of rural uplift and social welfare and was a prominent member of his locality. His career was full of promise and his death is greatly to be deplored. - (a) the names of persons who are at present undergoing implionement or are under any restrictive orders for their political activities
  - (b) whether any of them have been granted any allowance
  - (c) if so the name and the allowance given to each of them;
  - (d) whether Government propose to release them ?

The Hon'ble Mr. SRI KRISHNA SINHA: (a) At present there are no persons under orders of restriction of any sort for political activities. There, is, however, one political convict, namely, Babu Awadhesh Kumar Singh confined in the Bankipur Jail.

- (b) and (c) The answer is in the negative.
- (d) The case of Babu Awadhesh Kumar Singh is under consideration of Government.

Mr. MURLI MANOHAR PRASAD: Will the Hon'ble the Prime Minister kindly let the House know why the Government have taken so long a time to consider the case of the particular political convict, viz. Awadhesh Kumar Singh?

The Hon ble Mr. SRI KRISHNA SINHA: Because in the judge ment it is not clear that the gentleman has been convicted for political reasons. Therefore, I have called for other papers in that connection.

what steps the authorities concerned have taken or propose to take to prevent lawlessness referred to in the article, particularly the measures taken during the course of the last three months to provent people of the province travelling without ticket and with what result?

The Hon ble Mr. SRI KRISHNA SINHA: The answer is in the affirmative. Last August the Provincial Government issued orders for special escorts of armed and unarmed police on trains on the lines which were worst affected by the nuisance. Plain clothe constables were also placed in compartments to detect persons who pulled the communication cords and magistrates were deputed to try offenders on the trains. It was not possible to give immediate effect to the orders on account of the communical tension prevailing at that time but the Provincial Government are informed that considerable improvement has been effected.

Mr. MAHESH PRASAD SINHA: May I know if the steps taken by Government are on the personal experience of travelling by the Hon ole Ministers?

The Hon'ble Mr. Sal Krishna Sinha: No. It is based on reports of those who are expected to know it.

Rai Bahadur SYAMNANDAN SAHAYA: Is the House entitled to know something of the experience of Hon'ble Ministers?
