QUESTIONS AND ANSWERS.

- TOTAL AMOUNT OF HOUSE BUILDING LOANS GIVEN TO THE EARTH-QUAKE SUFFERERS, THE MAXIMUM AND MINIMUM AMOUNT GIVEN IN AN INDIVIDUAL CASE AND TO PLANTERS, ETC.
- 94. Rai Bahadur LACHHMI PRASHAD SINHA: Will' Government be pleased to state—
- (a) the total amount of house-building loans so far given to the earthquake sufferers in the province and the maximum and the minimum amount of such loan given in an individual case;
- (b) the total amount of such loans given to planters and the maximum and minimum amount of such loan given in such an individual case?
- Mr. W. B. BRETT: (a) Up to the 31st August Rs. 8,56,000 had been given out in loans under the Bihar and Orissa Natural Calamities Loans Act in Patna, Saran, Monghyr and Bhagalpur. About half a lakh has been given out in the other districts affected. The largest loan sanctioned is for Rs. 12,000. The smallest is believed to be for Rs. 100.
- (b) It is believed that no loans under this Act have been taken by planters, but exact information on this point is not available.

THE USE OF THE OLD GOVERNMENT HOUSE AT RANCHI.

105. Rai Bahadur LACHHMI PRASHAD SINHA: Will Government be pleased to state what use is being made of the old Government House building at Ranchi and what amount is being spent annually on its maintenance?

Mr. F. A. BETTERTON: The old Government House building at Ranchi includes the Darbar Hall and provides accommodation for the offices of the Private Secretary and Aides-de-Camp and for a Press and Post Office.

The approximate annual maintenance charge of the building is Rs. 1,500.

Mr. SACHCHIDANANDA SINHA: Will Government be pleased to state if there is no Darbar room, or any other room fit for holding a Darbar, in the new Government House?

Mr. F. A. BETTERTON: The answer is in the negative.
