SHORT NOTICE QUESTION AND ANSWERS.

SCARCITY OF POPULAR VARIETY OF CLOTH.

1. **Shri JAGANNATH SINGH** : Will the Hon'ble Supply Minister be pleased to state—

(a) whether Government are aware of the fact that cloth of popular variety has become scarce in the State in general and Shahabad in particular ;

(b) whether it is a fact that public are experiencing undue hardship and difficulty in getting cloth and sugar for marriage purposes in Sasaram Subdivision owing to the faulty administration of the local Price Control Office ;

(c) if answers to clauses (a) and (b) are in the affirmative, what action Government propose to take for making cloth and sugar available to the public on the occasion of the *Holi* and marriages ?

The Hon'ble Pandit BINODANAND JHA : (a) Government are aware of the fact that certain varieties of popular cloth, specially *Saris* have become scarce in the State. There is nothing particular about Shahabad.

(b) There is no information that the public in Sasaram are experiencing any special hardship or difficulty in getting cloth or sugar for marriage purposes owing to any fault in the local Price Control Office ; enquiry is being made and on receipt of the report necessary action will be taken to remove the difficulty, if any.

(c) Government are not only aware of the shortage of popular varieties of cloth but have been actively taking steps with the Textile Commissioner to meet this shortage with increased production and increased allotment of medium varieties of cloth particularly *Dhotis*, *Saris* and *Markins*. Steps to meet the shortage of *Saris* particularly have been pressed with the Textile Commissioner and he has increased the allotment.

(iii) Railway feeder roads and also other important roads.

In view of the limited finances available, a more ambitious programme is not possible at present.

(b) There is no such scheme under Public Works Department.

Shri MURLI MANOHAR PRASAD : Will Government be pleased to state if the decision of constructing and improving the four categories of roads just now enumerated by the Hon'ble Minister has been taken after consulting the Chief Engineer or is it likely that again the scheme will be given up?

The Hon'ble Shri BADRINATH VERMA : This programme has been drawn up after consulting the technical experts.

PAYMENT OF ENHANCED SALARY TO THE TEACHERS OF SANSKRIT TOLS.

18. Shri AWADH BIHARI JHA : Will the Hon'ble Minister in charge of Education Department be pleased to state—

(a) whether any provision has been made by Government for sometime past, for payment of salary at an enhanced rate to the teachers of recognised Sanskrit Tols in this State;

(b) if so, whether payment at the enhanced rate is being made to the teachers of all the recognised *tols* or to the teachers of some of the *tols* only;

(c) if the answer to the latter part of clause (b) be in the affirmative, why this discrimination is being made?

The Hon'ble Shri BADRINATH VERMA : (a) The reply is in the affirmative.

(b) The payment at the enhanced rate is made to all *tols* which were recognised on 31st March, 1949.

(c) The question does not arise.

Shri AWADH BIHARI JHA : Why the enhanced rate is not allowed to *tols* recognised after that date?

The Hon'ble Shri BADRINATH VERMA : Because when, the Government announcement was made only the cases of schools existing on 31st March, 1949, were taken into consideration. Government was committed to pay the revised scale of salaries only to those institutions.
