Khan Bahadur SAGHIRUL HAQ: Is it a fact that it was decided by Government to treat the subject of sugar industry under "Industries" on the "Transferred" side after the Simla conference was over?

Khan Bahadur SAGHIRUL HAQ: Will Government be pleased to state whether for the purposes of the Simla conference—the Sugar industry conference—this subject was treated by Government as a subject under the head "Commerce"?

Mr. B. K GOKHALE: It was not treated as a subject under 'Commerce'. As regards the representatives of the local Government, I would invite a reference to the answer given to clause (b) which shows who represented the local Government.

Babu GODAVARIS MISRA:, Is it a fact that at the conference Mr. Prior was the spokesman of Government and not the Hon'ble Minister for Education?

The Hon'ble Khan Bahadur SAIYID MUHAMMAD HUSSAIN: I myself went there and Mr. Prior also went and both spoke. (Laughter.)

Babu GODAVARIS MISRA: Is, it a fact that the Government view was put forward both by the Hon'ble Minister and by Mr. Prior or Mr. Prior spoke on his own behalf?

The Hon'ble Khan Bahadur SAIYID MUHAMMAD HUSSAIN: Mr. Prior put the Government view.

Maulavi MUHAMMAD ABDUL GHANI: Is it a fact that the Revenue Department dealt with the replies to the resolution on sugarcane put by Maulavi Shaikh Muhammad Shafi during the last Ranchi session?

The Hon'ble the PRESIDENT: That question does not arise.

- (c) Five terrorist prisoners have been transferred to the Andamans. No Civil Disobedience prisoner has been transferred. Other prisoners have been transferred from time to time at their own request.
- (d) The local Government have no information of any recent illness in the Andamans, and, so far as they are aware, no Bihari prisoner has died recently in the Andamans.
