Tuesday, the 30th March, 1948.

SHORT NOTICE QUESTIONS AND ANSWERS.

REMOVAL OF DOORS, ETC., FROM VACANT MUSLIM HOUSES.

24. Mr. MUHAMMAD NAUMAN : Will the Hon'ble Prime Minister be pleased to state—

(a) whether it is a fact that in village Nagarnosha (P.-S. Chandi, district Patna) a gang of Goalas is removing doors, breaking walls and removing wooden *kari* and girders from vacant Muslim houses and trying to create trouble with those Muslims who go there to look after their properties?

The Hon'ble Mr. KRISHNA BALLABH SAHAY : Reports received from local officers show that there have been five cases of theft of bamboos, bricks, etc., from vacant Muslim houses in the village. Four of the cases were reported by the chaukidars and one by a local Muhammadan. Eight persons have been charge-sheeted in one case while in other cases there is no evidence against any specific persons. Two constables are deputed daily to patrol the village and batch patrol of chaukidars has also been made and their work is supervised by officers. Government are prepared to consider the establishment of an out post in the village if the Muslim evacuees are really anxious to return to the village.

Mr. MUHAMMAD NAUMAN : Are Government aware that in that village a chaukidar was killed for giving information to the police?

The Hon'ble Mr. KRISHNA BALLABH SAHAY : Government want notice for that.

Mr. MUHAMMAD NAUMAN : May I know from the Hon'ble Minister whether those two constables who have been deputed there stay there for a week or something like that or not?

The Hon'ble Mr. KRISHNA BALLABH SAHAY : My answer is that two constables are sent daily to patrol the village.

Mr. MUHAMMAD NAUMAN : My information is that they come from the thana but they do not stay there.
