## UNSTARRED QUESTIONS AND ANSWERS.

PETITION FROM TENANTS OF VILLAGES SITUATED ON THE NORTH SIDE OF RIVER SIKBAHNA FOR REMISSION OF RENT.

## 108. Mr. BAIDYANATH MISRA: Will Government be pleased to state—

- (a) whether it is a fact that the tenants of the villages situated on the north side of the river Sikrahna in the police-stations Sugauli and Motihari, filed petitions before the Collector of Champaran and the Manager of the Bettiah Raj under Court of Wards for the remission of rent for last year and the previous years;
- (b) if the answer to clause (a) be in affirmative, whether the remission of rent has been, granted to the tenants; if not, why not;
- (c) whether they propose to make a thorough enquiry into the situation and grant an adequate remission in rent to the tenants of the area in question?
- Mr. KRISHNA BALLABH SAHAY: (a), (b) and (c) Information is being collected and will be made available to the hon'ble member when obtained.
- Mr. HARIVANS SAHAY: Will Government make the answer available in this session or after this session?

MANUFACTURE OF GUR, SUGAR AND SUGAR-CANDY FROM PALM JUICE.

- 333. Mr. TAJAMUL HUSAIN: Will Government be pleased to state—
- (a) whether they are considering the question of prohibition of intoxicants;
- (b) whether it is a fact that gur, sugar and sugar-candy can be manufactured from palm-juice;
- (c) if the answer to clause (b) be in the affirmative, whether they propose to start an industry, as an experimental measure for manufacturing gur, etc.; if not, why?
- Mr. SAYEEDUL HAQQ: (a) Government intend to make an experiment in prohibition in some selected areas.
  - (b) The answer is in the affirmative.
  - (c) The matter is under examination.

WITHDRAWAL OF THE PRIVILEGE OF PREPARING PACHWAI FROM THE ABORIGINES OF SINGHBHUM.

- 334. Mr. DEVENDRA NATH SAMANTA: Will Government be pleased to state—
- (a) whether it is a fact that aborigines in the province are privileged to prepare pachwai for their use and consumption;
- (b) whether it is a fact that a notification has been issued by Government withdrawing the privilege of aborigines to prepare pachwai in areas namely, Haldibani, Karandih, Parsudi and Ghaghidih, pargana Dhalbhum, district Singhbhum;
- (c) if the answer to clause (b) be in the affirmative, when the notification was issued;
- (d) whether Government are aware that since the issue of the said notification, a large number of aborigines of the said areas have been prosecuted, convicted and sentenced to pay fine of Rs. 25 or so, each, for preparing pachwai for their own use and consumption;
- (e) whether it is a fact that the aborigines of those areas sent a memorial to His Excellency the Governor of Bihar, with the prayer that the said notification may be withdrawn;
- (f) whether it is a fact that the said memorial has not been disposed of;
- (g) whether Government are aware that the aborigines of the areas have been much harassed by excise authorities after the issue of the said notification;
- (h) if the answer to clause (g) be in the affirmative, whether Government are taking any steps to redress the grievances of aborigines; if so, what; and if not, why?

Mr. SAYEEBUL HAQQ: (a) The concession of free home-brewing of pachwai for domestic consumption is allowed in the district of the Santal Parganas and is also allowed to the aboriginal tribes in certain areas of the districts of the Chota Nagpur Division and also in the Banka subdivision of the Bhagalpur district.

- (b) The reply is in the affirmative.
- (c) The notifications were issued in April, 1923, and in March, 1936.
- (d) Government have no information about this. When the privilege has been withdrawn from that area persons infringing the law are liable to prosecution under the Bihar and Orissa Excise Act.
  - (e) The reply is in the affirmative.
  - (f) The memorial has already been disposed of.
  - (g) There is no information.
  - (h) The question does not arise.
