SHORT NOTICE QUESTIONS AND ANSWERS

COUNTER-SIGNATURE OF R. R's.

51. **Shri DEOKI NANDAN JHA :** Will the Minister in charge of the Supply and Price Control Department be pleased to state—

(a) whether it is a fact that the system of counter signature of R. R's. has since been discontinued under orders of Government ;

(b) whether it is a fact that as a result of this stocks of cement are brought by spurious firms and sold without check, in black-market ;

(c) whether it is a fact that some District Magistrates have impressed upon the Government the necessity of reimposing the system of counter-signature of R. R's. ;

(d) if the answer to clause (c) be in the affirmative, will Government be pleased to state whether they are contemplating to reimpose the system of counter-signature of R. R's., if not, do Government propose to take some other suitable steps?

Shri HARI NATH MISHRA : (a) Government have never authorised the imposition of any such restriction on the delivery of consignment of cement.

(b) Government have no information.

(c) The District Officers of Darbhanga and Muzaffarpur, who had imposed this restriction without any authority, have suggested to Government to allow the continuance of this restriction.

(d) The first part's answer is in the negative. Government are examining how best to improve the supply of cement in north Bihar.

श्री बदरीनाथ वर्मा—मैंने कहा है कि शिक्षा विभाग से छात्रवृत्ति नहीं मिलती है।

BAR FOR THE STUDENTS OF UNRECOGNISED COLLEGES TO APPEAR IN THE UNIVERSITY EXAMINATION.

***596. Shri MANZOOR AHMAD :** Will the Minister in charge of the Education Department be pleased to state—

(a) whether the Bihar University has decided not to allow such Students to appear in Intermediate and B. A. Examinations as private candidates, who are studying in such colleges as have not been recognised or affiliated by the University ;

(b) how many such colleges are regularly holding classes have not been as yet affiliated to the Bihar University ?

Shri BADRI NATH VERMA : (a) The University recognises those Colleges only which are affiliated to the University. The students reading in institutions which are not affiliated to the University are not recognised as regular students of a college. These students are treated as private candidates and the Regulations which have been prescribed for such private candidates apply to them. The policy of the University in this regard is liberal and as a result 108 students have been allowed to appear as private candidates from the Tutorial College, Jamshedpur and 62 students from Educational Institutions at Ranchi.

(b) As these institutions are not affiliated to the University, the University has no record about them and Government is, therefore, unable to give any figures in this connection.

समस्तीपुर में गर्ल्स स्कूल का सस्कार द्वारा संचालन ।

*५९७। श्री वशिष्ठ नारायण सिंह—क्या मंत्री, शिक्षा विभाग, यह बताने की कृपा

करेंगे कि—

(क) क्या समस्तीपुर में बिहार सरकार किसी गर्ल्स स्कूल का संचालन अपने हाथ में ले रही है ;

(ख) यदि खंड (क) का उत्तर स्वीकारात्मक है तो वह कौन स्कूल है और सरकार उसका संचालन अपने हाथ में कब लेगी और अभी तक उसका संचालन क्यों नहीं लिया गया ?

श्री बदरीनाथ वर्मा—(क) उत्तर हां है।

(ख) सरकार ने म्युनिसिपैलिटी द्वारा संचालित बालिका माध्यमिक विद्यालय, समस्तीपुर को प्रान्तीयकरण का आदेश गत अगस्त माह में ही दे दिया है, लेकिन कुछ कठिनाइयों के कारण वह विद्यालय अभी तक नहीं लिया जा सका है। समस्तीपुर के डिप्टी इंस्पेक्टर को यह आदेश दिया गया है कि वे म्युनिसिपैलिटी के चेंबरमैन से स्कूल का चार्ज लेने के विषय में बात करें।
