राजमहल सबडिवीजन में कृषि के लिये धान के बीज का वितरण।

१५५। श्री जेठा किश्कु—क्या मंत्री, विकास (कृषि) विभाग, यह बतलाने की

कृपा करेंगे कि—

(क) क्या यह बात सही है कि संयाज परगता के अन्तर्गत राजमहल सबडिवीजन में कृषि विभाग के ऑफिसर सरकार द्वारा रखे गये हैं, यदि हाँ, तो उनका हेडक्वार्टर्स कहाँ हैं;

(ख) सरकार ने कृषि पदाधिकारी को केवल ऑफिस में काम करने के लिये रखा है या गरीब जनता के सामने कृषि कार्य के तरीके बतलाने के लिये;

(ग) क्या यह बात सही है कि सरकार कृषि पदाधिकारी को गरीब और धनी के बास्ते बीज के लिये धान इत्यादि अनाजों का नमूना दिखाने के लिये देती है, यदि हाँ, तो १९५२ और १९५३ साल में किन-किन बंगला, थाना और बस्ती में किन-किन आदिमियों को दिया गया था तथा उक्त आदिमियों के नाम क्या हैं?

श्री बीरचन्द्र पटेल (कृषि उप-मंत्री)—(क) यह बात सत्य है कि एक ग्रो मोर फुड ऑफिसर कृषि विभाग की ओर से राजमहल सबडिवीजन में रखे गये हैं जिनका हेडक्वार्टर साहेबगंज में है।

(ख) दोनों कार्य के लिये वे रखे गये हैं।

(ग) प्रश्न के प्रथम खंड का उत्तर स्वीकारात्मक है। दूसरे खंड के उत्तर में एक विवरण पुस्तकालय के भेज पर रख दिया गया है।

PARTICULARS OF THE MEDIUM IRRIGATION SCHEMES.

156. Shri SADANAND PRASAD: Will the Minister, incharge of the Development (Agriculture) Department, be pleased to state—

(a) the number of Medium Irrigation Schomes sanctioned for each subdivision of the State and the estimated expenditure involved therein;

(b) whether there are numerous suitable sites available in the district of Hazaribagh for such schemes;

(c) the reasons for the low number of such schemes in Giridih subdivision;

(d) the list of proposed sites for such schemes in Giridih subdivision during 1954?

Shri BIRCHAND PATEL (Dy. Minister, Agriculture): (a) A statement is given below.

(b) The reply is in the affirmative.

(c) Previously execution of such schemes was restricted only in Intensive Cultivation Block and as there was only one Intensive Cultivation Block in the subdivision there was no prospect of more execution of larger number of Medium Irrigation Scheme in the said Intensive Cultivation Block. The restriction of execution of Medium Irrigation Scheme in Intensive Cultivation Block alone has since been withdrawn and as such many more such schemes if practicable may be executed in the Giridih subdivision in due course.
