APPLICATION OF FOUL AND UNFAIR MEANS IN THE EXAMINATION.

103. Shri LAKSHMI NARAIN SINGH : Will the Minister in charge of the Education Department be pleased to state—

(a) who was in charge of the examination held for the selection of students for Netarhat Public School in the State in this year ;

(b) whether it is a fact that the Superintendent of examination for the Patna Collegiate School Centre came to know of a foul play that some examinees had changed their answer books ;

(c) whether it is a fact that he took statement of Deputy Inspector of Schools, Patna Sadr, and some other invigilators who also suspected some foul play by some students who had appeared at the examination ;

(d) whether it is a fact that the Superintendent of the Centre reported the matter to the higher authorities mentioning names of such students as were suspected to have used unfair means in the examination ;

(e) whether it is a fact that in order to hush up the matter some interested authorities who were in charge of the examination took lenient view on the ground that those suspected students had been awarded low marks hence no action was taken ?

Shri BADRINATH VERMA : (a) The preliminary examination for selection of students for admission to the Netarhat Public School was conducted by the Director of Public Instruction, Bihar.

(b) The answer is in the negative. No report was received from the Centre Superintendent of the Patna Collegiate School Centre to the effect that some examinees had changed their answer books.

The Centre-Superintendent however found that the stitches of two answer books were defective and he made a note on the cover of the answer papers.

(c) The answer is in the negative. Neither the Deputy Inspector of Schools, Patna City, nor the invigilators suspected any foul play by examinees. The invigilators were certain that no unfair means had been used by the examinees.

(d) The Superintendent of the Centre while forwarding the answer books invited the attention of the authorities to the answer papers these stitches had been found defective and loose. He also submitted a note that the invigilators were sure that no unfair means had been used by the candidates.

(e) The matter was thoroughly investigated under orders of Government and it was found that the allegations were malicious and baseless and no action was called for. Nobody tried to hush up the matter and there was nothing to be hushed up.

श्री लक्ष्मी नारायण सिंह—इस परीक्षा के जो एस० डी० ओ० इनचार्ज थे।

Shri TRIBENI KUMAR : Government have said that a thorough investigation had been made, may I know the terms of reference of the investigation ?

अध्यक्ष—आपने प्रश्न पूछने पर इन्क्वायरी करायी ?

श्री बदरीनाथ वर्मा—इसके पहले ही इन्क्वायरी हुई थी। किसी ने शिकायत की थी कि परीक्षा में गड़बड़ी हुई है तो उसके बाद सरकार ने उसकी जांच करायी।

श्री त्रिवेणी कुमार—क्या गड़बड़ी हुई थी ?

श्री बदरीनाथ वर्मा—उत्तर पेपर में गड़बड़ी हुई थी। चेंज वगैरह किया गया था।

१३०। श्री रमेश झा—क्या शिक्षा मंत्री यह बताने की कृपा करेंगे कि सहरसा उच्चंगल

विद्यालय को प्रांतीयकरण करने तथा उसे सरकारी प्रबन्ध में लेने का फैसला सरकार ने अब तक किया अथवा नहीं और यदि किया तो इस संबंध में अबतक क्या प्रगति हुई ?

श्री बदरीनाथ वर्मा—इस विषय पर डिवीजनल इंस्पेक्टर का प्रस्ताव और रिपोर्ट सरकार के पास आ गये हैं। भवन का एस्टीमेट और प्लान आ गये हैं। सरकार इस बात को जांच कर रही है। तदुपरान्त इस विषय पर निश्चय करेगी।

श्री रमेश झा—डिवीजनल सुपरिन्टेन्डेन्ट की क्या रिपोर्ट सरकार के सामने आयी है ?

श्री बदरीनाथ वर्मा—उनसे रिपोर्ट मांगी गयी थी कि स्कूल के संबंध में क्या खबर होगा। वे सब बातें आ गयी हैं।

श्री रमेश झा—जो रिपोर्ट डिवीजनल सुपरिन्टेन्डेन्ट के यहां से आयी है, उसको क्या सरकार सदन के सामने रखेगी ?

अध्यक्ष—इसकी कोई जरूरत नहीं है।
