PROSECUTION OF LEADERS IN THE DISTRICT OF MANBHUM.

140. Shri CHANDRA SEKHAR SINGH: Will the Chief Minister be pleased to state

(a) whether the attention of Government has been drawn to the joint statement issued by some members of Parliament, including Srimati Sucheta Kripalani and Sri N. C. Chatterjee, published in a prominent English Daily of Calcutta, in its issue of the 2nd March, 1954 in which serious allegations of prosecution of leaders of public opinion in the district of Manbhum as well as organised attempt to suppress the peaceful expression of opinion of the people of Serai-kella and Kharsawan, have been made against the Government of Bihar, and the Prime Minister of India has been requested to intervene to put an end to the prosecution of leaders of these regions;

(b) if the answer to clause (a) be in the affirmative will Government be pleased to state whether these allegations are correct, if

not, what is the exact state of affairs?

Shri KRISHNA BALLABH SAHAY : (a) The shower is in the affirmative.

(b) The allegations regarding prosecution of leaders in Manbhum, or the denial of fundamental rights of freedom of speech and expression of opinion are wholly incorrect, and Government take this opportunity of most emphatically repudiating them as entirely baseless. There has absolutely been no attempt to prosecute anybody for giving expression to his opinion or to deny him his fundamental rights of freedom of speech, nor do Government intend doing any thing of the kind, provided this right is exercised in a peaceful and lawful manner. In Manbhum, Government had to take action against some persons not for exercising their fundamental rights but for acting in an illegal way and in a manner which disturbed the peace or was prejudicial to maintenance of law and order. So also in Scraikella, action has been taken against those who have broken the

HOUSING ARRANGEMENT FOR REFUGERS.

*230. Shri YOGESHWAR GHOSH: Will the Minister incharge of the Relief and Rehabilitation Department, be pleased to state—

(a) whether it is a fact that the refugees who are putting up-in the Phulwari Camp Jail are being asked by the Government to vacate it;

(b) whether some alternative arrangement for housing has been

made for them?

Shri SHAH MUHAMMAD OZAIR MUNEMI: (a) In Government letter no. 1586, dated the 25th February 1954 the District Magistrate Patna, was requested to get the Phulwari Camp premises in occupation of the displaced persons vacated but by the present order of the Minister, the District Magistrate, Patna, is being requested to allow the displaced persons (should be allowed) to stay in the Camp until further order.

(b) 135 tenements have been constructed at Chitkohra where 94 families can be accommodated. Necessary improvements in the tenements are being made in order to make them quite habitable.
