आगामी आम चुनाव ।

A -५५ । श्री जयनारायण झा विनित : क्या माननीय मुख्य मंत्री यह बताने की कृपा करेंगे कि—

(क) क्या यह बात सही है कि आगामी आम चुनाव के लिए बिहार सरकार की ओर से बनाए गए क्षेत्रों की एक सूची पोलियामेन्टरी डि लिमिटेशन कमिटी को दी गई थी;

(ख) क्या यह बात सही है कि उक्त कमिटी ने अपनी अन्तिम रिपोर्ट दे दी है और उसकी प्रति बिहार सरकार के पास भी भेज दी गई है;

(ग) क्या यह बात सही है कि इस सरकार द्वारा बनाए गए क्षेत्रों से में कई क्षेत्रों में हेरफेर कर दिये गये हैं;

(घ) क्या सरकार उक्त कमिटी की रिपोर्ट की एक प्रति सभा के सदस्यों को देने की कृपा करेगी, तथा उस पर विचार करने का अवसर सदस्यों को इस सभा में मिलेगा ?

माननीय श्री कृष्णबल्लभ सहाय : (क) उत्तर हां है ।

## BOUNDARY LINE BETWEEN BIHAR AND THE UNITED PROVINCES.

\*1005. Shri JAGANNATH SINHA : Will the Hon'ble the Chief Minister be pleased to state—

(a) whether there is any proposal before Government to have a fixed boundary between Bihar and U. P. in the districts of Shahabad and Ballia instead of the present river boundary, the shifting course of which has led to many claims and counter claims ;

(b) whether it is a fact that preliminary investigations have been started as to the possibility of resolving the differences by negotiation ;

(c) whether there is any proposal to set up a boundary commission ;

(d) if answers to clauses (a), (b) and (c) be in the affirmative, the progress so far made in the said negotiations ?

The Hon'ble Shri KRISHNA BALLABH SAHAY : (a) The answer is in the affirmative.

(d) The matter is under negotiation with the U. P. Government.

Shri JAGANNATH SINHA : I wanted to know the progress already made because the question has been pending since a long time.

The Hon'ble Shri KRISHNA BALLABH SAHAY : I admit that the matter has been pending since long, but it has not been settled yet. A Boundary Commission was appointed for the purpose, but the Hon'ble the Chief Minister of Uttar Pradesh wrote to the Hon'ble the Chief Minister of Bihar that it would not help matters much if the matter is left to a Commission the Chairman of which was to be a Judge of the Bombay High Court, and he suggested that it would be better to start settling up the matter by direct negotiation between the two Governments. The Government of Bihar set up a Committee to work out the preliminaries and as soon as preliminaries are settled up we shall open the negotiation.
