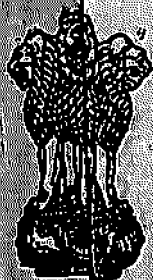

STARRED QUESTIONS AND ANSWERS.

DIRECTION OF DEVELOPMENT FOR CO-OPERATIVE MOVEMENT.

*29. **Shri RAM NARAIN CHOUDHURY** : Will the Minister, in charge of the Development (Co-operative) Department, be pleased to state whether it is a fact that the Government, Development Department, with a view to revitalise the Co-operative Movement in the State had directed in their letter no. 20-21/50/D-6529, dated the 13th July 1950, the Registrar, Co-operative Societies, and the Cane Commissioner and Joint Registrar, Co-operative Societies that Co-operative Societies within the Reserved and Assigned areas of the Sugar Mills, under the charge of the Registrar of Co-operative Societies, should get all the facilities given to Cane-Growers' Co-operative Societies in the matter of supply of cane ?

Shri DIP NARAIN SINHA : The answer is in the affirmative.

CO-OPERATIVE SOCIETIES.

* 30. **Shri RAM NARAIN CHOWDHURY** : Will the Minister, in charge of the Development (Co-operative) Department, be pleased to state—

(a) whether it is a fact that the Sugar Mills in general have been refusing to purchase cane from Multi-purpose Co-operative Societies which have amended their byelaws so as to include amongst their objects to sell cane grown by their members and thereby have become legally entitled under Section 2(g) of the Bihar Sugar Factories Control Act and Rules to be treated as Cane-Growers' Co-operative Societies ;

(b) whether it is a fact that the New India Sugar Mills, Ltd., Hasanpur Road (Darbhanga), has persistently been refusing for the last three cane seasons to purchase cane from the Multi-purpose Co-operative Societies under the Daulatpur Central Co-operative Bank, Ltd., P. O. Rusera (Darbhanga) situated in Reserved, Assigned

भूमि पर १५० रुपये खर्च बैठता है जो कि बहुत ज्यादा है। इस योजना को आर्थिक दृष्टि से उपयोगी बनाने के अतिरिक्त से स्थानीय पदाधिकारियों की विस्तृत जाँच-पड़ताल करने का आदेश दिया गया है, जिनकी सम्मति अभी तक प्राप्त नहीं हुई है।

(ख) इस योजना में पूरी छानबीन की आवश्यकता है, ज्योंही कुछ औद्योगिक (टेकनिकल) क्षेत्र कर्मचारी निर्माण कार्य से मुक्ति पायेंगे इस योजना का अनुसंधान कार्य सुचारु रूप से होने लगेगा।

(ग) जब तक इस योजना पर स्थानीय पदाधिकारी की अन्तिम सम्मति नहीं आ जाती है तब तक इस विषय पर निश्चित रूप से कुछ नहीं कहा जा सकता है।

श्री चन्द्रशेखर सिंह—उत्तर (क) से, डिटेल्ड इन्वेस्टिगेशन के लिये आदेश कब जारी किया गया?

श्री रामचरित्र सिंह—तारीख नहीं बताया जा सकता।

श्री चन्द्रशेखर सिंह—क्या सरकार को यह मालूम है कि यद्यपि आदेश दिये तीन महीने बीत गये फिर भी डिटेल्ड इन्वेस्टिगेशन अभी तक शुरू नहीं हुआ है?

श्री रामचरित्र सिंह—सरकार को मालूम नहीं है।

श्री चन्द्रशेखर सिंह—क्या सरकार इस पर विचार करेगी कि उसके आदेश का पालन हो?

श्री रामचरित्र सिंह—सरकार को खबर है कि उसके आदेश का पालन हो रहा है,

लेकिन जब माननीय सदस्य कहते हैं तो सरकार इस पर ध्यान देगी।

MAITHON DAM.

*349. Shri SATRUGHNA BESRA : Will the Minister in charge of the Irrigation Department be pleased to state—

(a) the names of the villages which will be submerged under the water of Maithon Dam ;

(b) whether it is a fact that there is danger of any village being submerged this year, if so, the names of such villages may be stated ?

Shri RAM CHARITRA SINHA : (a) A statement showing the names of village of the State which will ultimately be submerged is laid on the Library Table.

(b) No village will be submerged this year. A statement of villages which may be affected temporarily in case of sudden high flood this year is also laid on the table of the House.
