SHORT NOTICE QUESTIONS AND ANSWERS.

HUMBER OF COMMUNIST WORKERS ARRESTED OR PUT UNDER DETERTION.
IN THE PROVINCE SINCE MARCH 1948.

- 62. Mr. HARINATH MISHRA; Will the Hou'ble the Prime. Minister be pleased to state—
- (a) the number of communist workers that have been arrested or put under desention in the Province since March, 1948;
- (b) the names of the communist offices that have been searched since March, 1948, with incriminating materials, if any, found during the searches:
- (c) whether it is a fact that Government contemplate banning the communist party in the Province;
- (d) the action Government have taken or proposed to take against the Communist Party?

The Hon'ble Mr. BADRI NATH VERMA: (a) 13.

(b) So fat as information is available the fellowing C. P. J. offices were searched:—

Bottiah, Motihari, Chapra, Sonepur, Monghyr, Jamaipur, Bhagalpur, Bogusarni, Koldiha, Katihar. Darbhanga, Gaya, Ranchi, Sasaram, Dehri (Public Works Department Union Office), Petna, Janashakti Press, Patna, Muzaffarpur town.

Dhanbad, Alkusa-Nayadih Balliery Collieries Union Offices at Kenduadih, Bhowrah Colliery Union Office at Jorapokhar, Giridih Coal Workers' Union Office, Mica Mazdoor Union Office, Balram Workers, Union Office Amlabad, Manbhum.

A wireless set bearing No. BC-348-K-sorial no. 1357, Signal Corps United States Army was recovered from the C. P. I. Office Bettiah.

A copy of the prescribed book entitled "Operation Asylum" was found at the C. P. I. Office Bettiah and Motibari.

(c) and (d)—It will not be in the public interest to disclose the course of action Government propose to follow.

Action already taken by Government is known to the hon'ble members from the reply to (a).

The Hon'ble Dr. SRI KRISHNA SINHA: The rule—Appendix 42, Police Manual—under which Steno-Sub-Inspectors were required to be transferred to executive duties ordinarily after 5 years of service as Steno-Sub-Inspectors was cancelled in 1938 and the cadre of Steno-Sub-Inspectors was completely separated from the general cadre of Sub-Inspectors. The cadre of Steno-Sub-Inspectors has now been replaced by a cadre of Steno-clerks and the existing Steno.-Sub-Inspectors are being absorbed as quickly as possible in the general line.

PHYSICAL CONDITION OF THE DIVISIONAL FOREST OFFICER, MONGHYR FOREST DIVISION.

- (a) whether it is a fact that the Forest Officer posted at Monghyr, or Dinsi is suffering from gout and a particular kind of paralysis:

- (c) whether it is a fact that the particular kind of disease referred to in clauses (a) and (b) has made him physically unfit;
- (d) the number of miles a forest officer is required to walk into the jungle?

The Hon ble Mr. KRISHNA BALLABH SAHAY: (a) The Forest Officer posted at Monghyr is not suffering from paralysis. The present Divisional Forest Officer damaged his feet very badly while extinguishing a forest fire and he occasionally suffers from pain in the feet which some doctor diagnosed as Rheumateid Arthritis.

- (b) No part is affected by paralysis.
- (e) No, he is not physically unfit. Recently he toured with the Conservator of Forests and accompanied him every where.
 - (d) It all depends on the work one has to inspect.
