## SHORT NOTICE QUESTIONS AND ANSWERS.

#### LILA DEEP TRUST

- 116. Shri RAMESH JHA: Will the Minister in charge of the Judicial Department be pleased to state—
- (a) the total gross income from all sources per annum of Lila Deep Trust Estate from the time the Estate came into the possession of the Official Trustee;
- (b) the total collection and management charges per annum during the above period of the said Trust Estate;
- (c) the saving per annum during the above period in the said Trust Estate;
- (d) whether any portion of the accumulated savings of the said Trust Estate has been utilized so far for any of the purposes of the Trust;
- (e) if the answer to clause (d) be in the affirmative, what are the name or names of Institutions or the purposes for which the accumulated savings or any portion thereof has been utilized.

SHRI SHIVANANDAN PRASAD MANDAL: (a), (b) and (c) A statement is placed on the Library table.

(d) and (e) Rs. 17,000 is being paid annually out of the savings of the estate in the following manner:—

1: Srimati Prabhavati Devi . . . 9,000
2. Ramanandy Anathalaya, Bhagalpur . . 3,000

- (b) whether Government now propose to make settlement of the said range by auction like other forest;
- (c) if the answer to the above clauses be in the affirmative, whether Government think to give wider publicity of the same so that further exploitation be not made by the old lessee?

SHRI KRISHNA BALLABH SAHAY: (a) The answer is in the affirmative.

- (b) Government Lave decided to settle forests on long term lease system for a period of 3 years after calling for tenders.
- (c) As usual, tender for the settlement of these forests will be invited through the Press.

#### LEASE, OF BAILWAY RELINQUISHED LANDS AT PAHLEZA.

- 187. SHRI RAM BINOD SINHA: Will the Minister in charge nof the Revenue Department be pleased to state—
- (a) whether it is a fact that there are some Railway relinquished lands in Pahleza in Saran district;
- (b) whether it is a fact that these lands were leased out to some persons of the area but have been taken back and leased out to other persons this year;
- (c) whether it is a fact that due to this change there has been a serious breach of peace and there is apprehension of breach of peace still;
- (d) whether it is a fact that this change has been made only with the intention of not allowing the old lessees to get occupancy-right in the lands after twelve years;
- (e) whether it is a fact that no such right can legally accrue in such lands and the Commissioner, Patna Division, has expressed his opinion as such;
- (f) if the answers to the above clauses be in the affirmative. why do the Government not let the lands remain in the hands of the old lessees and thus stop the occurrence of serious breach of the peace?

SHRI KRISHNA BALLABH SAHAY: (a) The answer is in the affirmative.

(b) Some such lands in Pahleza diara have been settled with original tenant in preference to one Shri Bhagwan Rai who had taken settlement of the land of the original tenant Shri Bhola Rai for one year in 1947-48 after which the land diluviated.

- (c) Last year the land alluviated and Shri Bhagwan Rai wanted to take forcible possession and Shri Bhola Rai the original tenant protested on which a breach of peace occurred and a criminal case is pending in a Patna Court.
  - (d) The answer is in the negative.
- (e) No occupancy right accrues as already decided by the Additional Commissioner, Tirhut, in case no. 1065 of 1951-52.
- (f) The question does not arise as the settlement in the case has been done with the original tenant.
