TROOP-TRAIN DERAILMENT.

A *33. Shri JAGANNATH SINGH: Will the Hon'ble Minister in charge of the Communications be pleased to state—

- (a) whether the attention of Government has been drawn to the news published in the Dak Edition of a local English daily, dated the 20th July, 1951, under the caption 'Troop-Train Derails near Motihari—suspected sabotage by Pakistan Agents';
- (b) if the answer to clause (a) be in the affirmative the full facts of the accident and whether the derailment was caused by the sabotage of Pakistani agents?

माननीय श्री ग्रव्दुल क्यूम ग्रन्सारी-(क) उत्तर स्वीकारात्मक है।

- (ख) (१) १८ जुलाई, १६५१ को रात में २ वज कर ५ मिनट पर १०१ अप पैसेन्जर मुजफ्फरपुर से खुली। प्रातःकाल ४ वज कर ४५ मिनट पर जब ट्रेन मोतोहारी स्टेशन से २ मील और मुजफ्फरपुर को ओर से १००/२१ मील पर पहुँची, तथा जब धनौती पुल पर पहुँचने में २७६ फीट की दूरी पर थी तब यह पटरी से उतर गयी। इंजिन का एक पिछला डब्बा (जनानी तथा ड्योंडा दरजे का) रास्ते की दाहिनी तरफ उलट गया; किन्तु इंजिन से जुटा रहा और इंजिन रास्ते से नहीं हटी। उसके दूसरे डब्बे का चक्का पटरी से उतर गया और डब्बा नीचे के ढ़ाचें (चैसिस) से अलग हो गया। उसके पीछे का तीसरा डब्बा इंजिन की ओर उलट-पुलट कर रह गया। कोई व्यक्ति मरा नहीं और ११ व्यक्तियों को माम्ली चोट आयी थी जिनको निकट की पुलस लाइन के लोगों द्वारा शीघ ही आवश्यक सहायता दी गयी।
- (२) ऐसा मालूम होता है कि किसी अज्ञात उपद्रवकारी ने दो जोड़े फिब प्लेटों की खोल दिया था जिसके कारण रेल पटरी से उतर गयी। अतएवं यह तोड़-फीड़ का मामला मालूम होता है। इस बात की अभी गुप्त रूप से जांच पड़ताल की जा रही है कि इस दुर्घटना का जिम्मेवार कौन है।

श्री जगन्नाथ सिंह—में जानना चाहता हूँ कि इस सम्बन्ध में किसी की गिरफ्तारी हुयी है या नहीं?

- (ग) जी हां ; सर्किल नं० १ के सरकारी रेलवे निरीक्षक ने इस दर्घटना के कारणों की जांच की जिसके फलस्वरूप करौता का सुईचमैन प्रधान दोषी पाया गया । माल-गाडी के श्रीर १५ ग्रप एक्सप्रेस के डाइवर भी इसके लिये श्रपराधी ठहराये गये हैं। यदि पूलिस ने इनलोगों पर फौजदारी मुकदमा नहीं चलाया तो विभागीय कार्रवाई की जायगी।
- (घ) इस दुर्घटना से २२ मनुष्यों को साधारण चोट पहुँची और लगभग २२,७०० रुपये की क्षति रेलवे को उठानी पड़ी।
- (ङ) इस प्रकार की दूर्घटनाम्रों से वचते के लिये यह निरुचय किया ग्रमा है कि मेन लाइन के सिगनलों को ब्लॉक इन्सट्र्मेण्ट के द्वारा बन्द किया जाय । यह व्यवस्था ग्रैन्ड कार्ड लाइन में लागू की गयी है श्रीर धीरे-धीरे मेन लाइन में भी की जायगी परन्तु कार्य बहुत बड़ा है इसलिये कुछ समय लगेगा । इस प्रबन्ध से अविषय से इस प्रकार की दुर्घटनात्रों की संभावना कम हो जायगी।

श्री जयनारायण झा 'विनीत '- क्या सरकार बतलाय गी कि जो दुर्घटनाय ही रही हैं उनमें किसी किस्म की साजिश की बात है या नहीं?

माननीय श्री अब्दुल क्यम अन्सारी-जहां तक रिपोर्ट का ताल्लुक है इससे साबित नहीं होता है कि इसमें कोई साजिश है।

Shri PURUSHOTTAM CHAUHAN: May I know why the police has not instituted any case?

The Hon'ble Shri ABDUL QAIYUM ANSARI: I cannot say just now. I have no report before me here.

Shri PURUSHOTTAM CHAUHAN: I want to know the reason why the police has not instituted any case?

The Hon'ble Shri ABDUL QAIYUM ANSARI: I cannot say anything just now.

Shri PURUSHOTTAM CHAUHAN: I want to know when you will be able to do so?

The Hon'ble Shri ABDUL QAIYUM ANSARI: When the hon'ble member would give a fresh notice of the question.

CONTROL OF SECONDARY EDUCATION.

- *66. Shri AWADH BIHARI JHA: Will the Hon'ble the Minister in charge of the Education Department be pleased to atate.
- (a) whether the State Government intend to enact a legislation to control the Secondary Education in this State; if so, in what stage the matter stands

(b) whether such an enactment is likely to be finalised and given effect to in the course of this year?

The Hon'ble Shri BADRI NATH VERMA: (a) The answer is in the affirmative.

(b) It is not likely.

Shri AWADH BIHARI JHA: Sir, my question is that, in what stage the matter stands?

The Hon'ble Shri BADRI NATH VERMA: The materials are ready and the matter is to come up before the Council of Ministers.

Shri AWADH BIHARI JHA: May I know when this legislation would be placed before the Legislature?

The Hon'ble Shri BADRI NATH VERMA: No definite time can be given, especially in view of the General Elections.

Shri JAGANNATH SINGH: I would like to know whether Government propose to consult the representatives of the teachers before drawing up the main outline of the proposed legislation?

The Hon'ble Shri BADRI NATH VERWA: There is a good deal of materials already collected and the report of the committees appointed in this connection is also available. When the Bill is drafted it will be published for opinion.

Shri JAGANNATH SINGH: When the committee was appointed ?
The Hon'ble Shri BADRI NATH VERMA: In 1937-38.

Shri JAGANNATH SINGH: Who were the members of the Committee?

The Hon'ble Shri BADRI NATH VERMA: I cannot give all the names just now but the committee consisted of Mr. K. T. Shah, Dr. Rajendra Prasad and Dr. Zakir Hossain. There were some others also.

Shri JAGANNATH SINGH: Does the Hon'ble Minister refer to the University Reorganisation Committee under the presidentship of Mr. K. T. Shah or was it a separate committee regarding Secondary Education?

The Hon'ble Shri BADRI NATH VERMA: The same committee considered education in all its aspects from the primary stage to the university stage.

Shri JAGANNATH SINGH: I should like to know that as the said committee was constituted more than a decade back, do Government now consider it necessary to consult the educationists and representatives of the teachers in view of the fact that there have been many changes since then?

The Hon'ble Shri BADRI NATH VERMA: Since then, the matter has been reviewed, from time to time by the Central Advisory Board of Education and is also receiving consideration of the Government of India who have appointed a committee.

Shri JAMUNA PRASAD SINGH: Was it not advantageous to take up this measure along with the two other Bills—now Acts?

The Hon'ble Shri BADRI NATH VERMA: I could not follow what the hon'ble member wants to know.

Shri JAMUNA PRASAD SINGH: Sir, was it not advantageous to take up this measure along with the two University Bills—now Acts?

The Hon'ble Shri BADRI NATH VERMA: I cannot follow what the hon'ble member exactly means.

Shri JAMUNA PRASAD SINGH: I mean to say that it would have been better that all the three legislations—i. e., the two legislations on University Bills and the third on Secondary Education—all these three could have been taken together.

The Hon'ble Shri BADRI NATH VERMA: Not necessarily.

Shri PURUSHOTTAM CHAUHAN: May I know whether all the materials are ready so that the matter may come up in the Legislature very early?

The Hon'ble Shri BADRI NATH VERMA: I have already replied that the matter is coming up before the Council of Ministers. There are so many things there which require the orders of Government. Only when all these things are done then the matter be brought before the Legislature.

Shri NAND KISHORE NARAYAN LAL: Sir, is it a fact that for want of suitable legislation and amendments in the Education Code, proper control and supervision is not possible with regard to the institutions under the Secondary Education Board?

The Hon'ble Shri BADRI NATH VERMA: That is a matter of opinion but it is certain that the secondary education requires recrientation and reorganization like any other.

Shri NAND KISHORE NARAYAN LAL: Is it a fact that several cases of corruption and embezzlement have been reported to Government?

The Hon'ble Shri BADRI NATH VERMA: Such things occur everywhere.
