- 13. Mr. SARANGDHAR SINHA: Will the Hon'ble Minister of Education be pleased to state—
- (a) if his attention has been drawn to a news published in one of the local English dailies in its issue of the 7th March, containing two serious allegations against the conduct of the Headmaster of the Patna Collegiate School, viz., (a) that he removed Gandhiji's portrait from a class-room and put up in its place a portrait of Clive, and (b) that he threatened certain students who had attended Gandhiji's funeral in Delhi with expulsion from school;
- (b) if he has had any enquiry made into the truth or otherwise of the aforesaid report;
- (c) if the answer to clause (b) be in the negative, the reasons for not ordering an inquiry immediately;
- (d) if the answer to clause (b) be in the affirmative, the result of the inquiry?

QUESTIONS AND ANSWERS.

SEPARATION OF EXECUTIVE AND JUDICIAL FUNCTIONS IN BIHAR.

- 58. Mr. JHULAN SINHA: Will the Hon'ble the Prime Minister be pleased to state-
- (a) the decision arrived at by Government with regard to separation of the Judiciary from the Executive;
- (b) the date on which the Committee recommending a detailed scheme for the said separation was last constituted and on which date is submitted its proposal;
- (c) the action that has so far been taken on the recommendation of the Committee?

The Hon'ble Dr. SRI KRISHNA SINHA; (a) Government have decided to separate the Executive and Judicial functions within the exicting frame work of the Code of Criminal Procedure.

- (b) The Committee was appointed on the 1st December, 1946. It submitted its report on the 16th January, 1947.
- (c) The details of the scheme are being worked out by a Special Officer appointed for this purpose.

Mr. JAMUNA PRASHAD SINGH: What do Government mean by the qualifying phrase " within the existing frame work of the Code of Oriminal Procedure"?

The Hon'ble Dr. ANUGRAH NARAYAN SINHA: It is absolutely clear. The hon'ble member ought to understand the meaning.

Mr. JAMUNA PRASHAD SINGH: Is it not a complete separation of Judicial from the Executive?

The Hon'ble Dr. ANUGRAH NARAYAN SINHA: It is not

Mr. JAMUNA PRASHAD SINGH: When the work of the separation is going to begin?

The Horbie Dr. ANUGRAH NARAYAN SINHA I Examination has started and as soon as the examination is complete, it will be introduced in two districts, to begin with.

The Hon'ble Dr. ANUGRAH NARAYAN SINHA: Patna and Gaya.

OTTER LACK OF IRRIGATIONAL FACILITIES IN THE NON-CANAL AREAS OF THE SASARAM SUBDIVISION.

- 59. Mr. JAGANNATH SINGH: Will the Hon'ble Minister in charge of the Irrigation Department be pleased to state.
- (a) whether it is a fact that there is an utter lack of irrigational facilities in the non-canal areas of the Sasaram Subdivision where people are facing conditions bordering on famine this year;
- (b) the number of irrigation schemes sanctioned and executed reparately for this area during the last twenty months of the popular egime;
- (c) the number of petitions received from the people of the Sasaram Subdivision for irrigational facilities, thanawise, and the action taken in each case;
- (d) whether Government propose to take any steps in the near future for ensuring irrigational facilities to the people of the aforesaid areas which are often visited by partial famines?

The Hon'ble Mr. RAM CHARITRA SINHA: (a) It is not a fact that there is an utter lack of irrigational facilities in the non-canal areas of irrigation from small storage reservoirs locally known as "Ahars" besides

- (b) 16 emergency tube-wells and 3 Provincial tube-wells have been constructed by Government during the year 1946-47.
- (c) Only two petitions have so far been received from the people of the Sasaram Subdivision. One is from police-station Tilothu for Chandanpur and the other is from police-station of pyne in the village struction of a bandh in the river Thora near Rambandh Tola in the village Akorha.

The proposals are under investigation.

(d) The question of Development of Son-Canals system which is likely to serve this area also, is interlinked with the construction of Rehand (Pipri) Dam in United Provinces and is receiving active consideration of Government.
