- "(3) that the said encroachments are viewed by the people as oppressive and create a feeling of discontent and distrust against the Government?
- "(b) Will the Government be pleased to make thorough enquiry into the matter and take such steps as may be deemed necessary to put a stop to such encroachments in future and to remedy those already made whether after the cadastral survey or prior to that survey but within the period of limitation?"

The Hon'ble Mr. Sifton replied :—

"Government have made enquiry and ascertained that within the last two Years and a half no complaints of the kind suggested in this question have been made. Any person who considers himself aggrieved in this way should make his complaint in the first place to the Chairman of the Board.

"As a matter of fact it is the District and Local Boards which have most cause for complaint. Private individuals are constantly encroaching upon lands pertaining to the public roads by surreptitiously removing boundary marks and ploughing up road-side lands a little at a time or building over them by slow and often imperceptible degrees."

The Hon'ble Maulavi Saiyid Nurul Hasan asked:—

"Will the Government be pleased to state when the Bill regarding Introduction adulteration of ghi and other articles of diet is likely to be introduced in the the Food Adultera-Legislative Council?"

The Hon'ble Mr. Sifton replied:

"The Local Government have completed the draft of the Food Adulteration Bill and expect to introduce it into Council early in the next session."

The Hon'ble Mr. Tanner replied :---
