BIHAR VETERINARY COLLEGE AFFAIRS.

A*149. Shri NAND KISHORE NARAYAN LALL : Will the Hon'ble Minister in charge of the Development Department be pleased to state—

(a) the number of students who appeared at and passed in the last preliminary B. V. Sc. Examination under the Patna University and the percentage of result ;

(b) whether it is a fact that the Principal of Bihar Veterinary College does not hold degree but only a diploma and Professor of Anatomy is non-matric but has been given class II post without any foreign or technical qualification ;

(c) whether it is a fact that the Professor of Surgery holds no degree nor any foreign or Indian qualification but is only a simple G. N. Vs. and is second class officer and the students are not satisfied with his teaching ;

(d) whether it is a fact that the affairs of Veterinary College are not satisfactory ;

(e) if the answers to the clauses (a) to (d) be in the affirmative what action Government propose to take to improve the efficiency of the College, if not, the reasons for the same ?

Shri BIRCHANDRA PATEL : (a) The number of students who appeared in the last B. V. Sc. preliminary examination of the Patna University was 80. Out of these, 33 passed and 11 were placed in compartment. The percentage of pass was 41.2.

(b) The reply to first part of the question is in the affirmative. The diploma which the Principal holds is regarded as the highest veterinary qualification in the world for a practising veterinary surgeon. There is no post of surgeon. There is no post of Professor of Anatomy in this college. There is, however, a post of Assistant Professor

APPOINTMENT OF CANE ORGANISERS.

*278. **Shri JAGANNATH SINGH :** Will the Hon'ble Minister in charge of Development Department be pleased to state—

(a) the principles and the procedure followed in making appointment of Cane Organisers by the Cane Commissioner ;

(b) whether it is a fact that many applicants with better University results and academic qualifications could not be appointed, if so, why ;

(c) the total number of political sufferers appointed as Cane Organisers, the basis of their appointment and how many of these were recommended by the Provincial Political Sufferers' Committee ;

(d) whether it is a fact that appointment authority paid scanty attention to the recommendation of the President of the Bihar Political Sufferers' Committee in making appointment of the candidates as Cane Organisers who were political sufferers, if so, why ?

Shri BIR CHANDRA PATEL : (a) Applications were called for and according to the terms of the advertisement persons from among the applicants were selected for interview and those who did well at the interview were selected for a written test, and the result of the test examination and consideration like the fact of being a political sufferer guided the final selection for the appointment to the post of Cane Organisers.

(b) The answer is in the affirmative. There were persons with better University results and academic qualifications but on account of the preference being shown to the political sufferers some of the posts could not be given to them.

(c) Out of 10 appointments the number of political sufferers was 6, that is 60 per cent. These 6 candidates have done well both at the interview and at the written test and they were found otherwise suitable also. The fact of their being political sufferers counted for preference over those who had slightly better academic qualifications. The Provincial Political Sufferers' Committee had not recommended any candidate for appointment particularly.

(d) The answer is in the negative. Due attention was paid by the appointing authority to the recommendation of the President of the Political Sufferers' Committee generally. The President of the Committee addressed a letter to the Chief Secretary in regard to a political sufferer, namely, Shri Sheopujan Rai, who was a candidate for the post of Cane Organiser. On receipt of this letter the appointing authority examined the position of the candidate

and the test results and found him to be below others. The appointing authority then discussed this matter personally with the President of the Committee and apprised him of the correct position regarding the selection made and the President was fully satisfied at the share of the political sufferers in the total appointments and had no particular recommendations to make after the discussion.

Shri PRABHUNATH SINGH : Who were the.....

The Hon'ble the SPEAKER : I take it that Shri Jagannath Singh, in whose name the question stands, has no supplementary to put.

Shri PRABHUNATH SINGH : Who were the political sufferers appointed ?

Shri BIRCHANDRA PATEL : I have no names of political sufferers with me now, I can say only this much that 6 out of 10 were appointed on the ground of their being political sufferers.

Shri PRABHUNATH SINGH : Will Government be pleased to state the names of those persons who were appointed, their address and their political sufferings ?

Shri BIRCHANDRA PATEL : I am sorry I not in possession of the names just now. If the hon'ble member gives notice, I will produce the names.

Shri PRABHUNATH SINGH : Do Government propose to send the names of the political sufferers, who have been appointed, to the President of the Committee ?

Shri BIRCHANDRA PATEL : Government have no objection to send the names to the President.

Shri JAGANNATH SINGH : With your permission, Sir, I want to put a supplementary as I could not exercise my right.....

The Hon'ble the SPEAKER : I called out the name of the hon'ble member when his turn came but his wilful and determined default was there and I cannot extend the concession now.

Shri JAGANNATH SINGH : My supplementary arises from the question of.....
