Mr. BIR CHANDRA PATEL: Scientific methods have been followed to supply manure to the needy persons as far as it is humanly possible to do so. I admit there may be cases in which they might commit mistakes.

Mr. JAGANNATH SINGH: The first part of the question (b) has not been answered.

Mr. BIR CHANDRA PATEL: The reason for the delay in making the payment was that in this particular region, the Deputy Director of Agriculture wanted personally to check the bills.

Mr. JAGANNATH SINGH: How many months were taken by the Deputy Director?

Mr. BIR CHANDRA PATEL: Government may assure the hon'ble member that this matter will be enquired into and steps will be taken to see that no such delay occurs in the future.

Mr. JAGANNATH SINGH: May I know if Government is in a position to answer whether payment has been made after the receipt of the question?

Mr. BIR CHANDRA PATEL: Government think payment should have been made, but we are not sure. Government have received no information.

DAMAGE OF AGRICULTURAL OROPS BY WILD ANIMALS IN PALAMAU DISTRICT

- (a) whether it is a fact that the agricultural crops are damaged in the district of Palamau by the wild animals for want of weapons to scare away such animals;

The Hon'ble Dr. SAIYID MAHMUD: (a) It is a fact that crops are damaged by wild animals in part of the district covered by thick junglea and also in other districts where there are diaras.
