DECLARATION OF CONTROLLED AREA.

A127. Shri RAM KHELAWAN SINHA: Will the Minister-incharge of Local Self-Government Department, be pleased to state—

- (a) whether any portion of Patna Town has been declared a controlled area by a recent notification, if so, when and what areas;
- (b) why such a vast area of the Patna Municipal Corporation has been declared a controlled area;
- (c) what are the specific advantages for the public and the Government respectively by this declaration of the controlled area;
- (d) whether it is a fact that the effect of this declaration on the public with respect to purchase and sale of lands and houses will be very harmful?

Shri BHOLA PASWAN: (a) The answer is in the affirmative. As regards the areas, Government's notification no. 1673--L. S.-G., dated 15th February, 1954, published at page 753 of the Bihar Gazette, dated 23rd February, 1954 may be perused.

- (b) Patna has grown very rapidly since the last war and the growth has been very haphazard and even insanitary. The drainage system of Patna is very defective and therefore it has become necessary that there should be planned development and the future growth of Patna should be controlled.
- (c) Under the Restriction of Uses of Land Act, the District Magistrate has powers to pass plans of houses to be constructed and he has to take advice of the Town Planner in his decision. Government have under preparation a Master Plan of Patna and it is contemplated that the future growth of Patna will be regulated by the Master Plan. Public have the benefit of the technical advice of the Town Planner in the matter of planning and sitting of houses.
