PROSCRIPTION OF THE PRAYER ISH VINAYA AND THE INTRODUC-TION OF THE PRAYER IN SCHOOLS UNDER THE DARBHANGA DISTRICT BOARD.

Babu GIRINDRA MOHAN MISRA: (a) Wills the Hon'ble Minister of Education be pleased to state if he was aware of the prayer entitled Ish Vinaya having been prescribed by the district board of Darbhanga for being recited by the boys of the primary schools, before the same was declared seditious and proscribed by a Government notification?

(b) If the answer to (a) be in the affirmative:

(i) Will the Hon'ble Minister of Education be pleased to state how long before the publication of the notification he came to know of it?

(ii) Did he receive any report from any officer of the educational service regarding the aloresaid Ish Pinaya having been prescribed by the district board?

(iii) Did he take any action in respect of it after he came to know of it? If so, what?.

(iv) If he did take action in the matter did he ever bring to the notice of the Hon'ble Minister of Local Self-Government that such action had been taken?

(c) If the answer to (a) be in the negative:

Mr. JIMUT BAHAN SEN: Was it decided by a majority? The Hon'ble Mr. E. L. L. HAMMOND: That, Sir, is a question which the hon'ble member is not entitled to ask and

The Hon'ble the PRESIDENT: The hon'ble member is certainly entitled to ask that question. Whether the Hon'ble Leader of the House will answer the question or not is entirely within his own discretion. But I cannot disallow the question.

The Hon'ble Mr. E. L. L. HAMMOND: I thought it was a question about the personal opinion of the officers of Govern-

The Hon'ble the PRESIDENT: It is not a question about personal opinion. The question was whether the decision was

arrived at by a majority. He is entitled to ask that question, but it is open to Government to decline to answer it on public grounds if they are so advised.

The Hon'ble Mr. E. L. L. HAMMOND: When an order was passed, naturally enough there must have been a majority in its favour.

Mr.'JIMUT BAHAN SEN: Was it a unanimous decision?

The Hon'ble Mr. E. L. L. HAMMOND: That question of course I decline to answer.

Khan Bahadur SHAH MUHAMMAD YAHYA: Has the district board got any power to prescribe any particular prayer for any school which contains boys of different religions?

The Hon'ble Mr. E. L. L. HAMMOND: Not without the sanction of my Hon'ble Colleague, the Education Minister.

Mr. SAIYID MUHAMMAD ATHAR HUSAIN: Has the Hon'ble Minister given any sanction?

The Hon'ble Sir SAIYID MUHAMMAD FAKHR-UD-DIN, Khan Bahadur: No such application has ever been made.
