- (c) whether it is a fact that Government contemplate banning the communist party in the Province;
- (d) the action Government have taken or proposed to take against the Communist Party?

Dhanbad, Alkusa-Nayadih Balliery Collieries Union Offices at Kenduadih, Bhowrah Colliery Union Office at Jorapokhar, Giridih Coal Workers' Union Office, Mica Mazdoor Union Office, Balram Workers, Union Office Amlabad, Manbhum.

A wireless set bearing No. BC-348-K-sorial no. 1357, Signal Corps United States Army was recovered from the C. P. I. Office Bettiah.

A copy of the prescribed book entitled "Operation Asylum" was found at the C. P. I. Office Bettiah and Motibari.

SETTLEMENT OF KHASMAHAL LAND FOR BUILDING HOUSES IN PAINA.

- 71. Mr. JADUBANS SAHAY: Will the Hon ble Minister in charge of Revenue Department be pleased to state-
- (a) if it is a fact that the Government, during the last session of the Assembly at Ranchi, had stated that lands for building houses in Patna were alletted to Mr. Justice Manchar Lat, Mr. P. R. Das and Dr. Raghunath Saran :
- (b) if it is a fact that the order of the Government regarding the aforesaid settlement has not been communicated to them;
- (c) whether Government propose to take immediate steps for finally settling the lands with them ?

The Hon'ble Mr. BADRINATH VERMA: (a) The answer is in the affirmative.

Dr. SACHCHIDANANDA SINHA: How long is it likely to be under the consideration of Government? Million years?

The Hon'ble Mr. BADRI NATH VERMA: As long as it would be accessary.

Mr. JAMUNA PRASAD SINGH: Were these lands settled with these three persons lying useless at the hands of the Khas Mahal?

The Hon'ble Mr. BADRI NATH VERMA: The lands had not been in use.

Mr. JAMUNA PRASAD SINGH: Was any advertisement made about the settlement of these lands before the lands were settled with

The Hon'ble Mr. BADRI NATH VERMA: No advertisements were made.

Mr. JAMUNA PRASAD SINGH: What is the reason? Is it a fact that advertisements are generally given by the Khas Mahal Officers before such lands are settled with the public?

The Hon'ble Mr. BADRI NATH VERMA: This was not a question of general settlement. Certain gentlemen had applied for certain pieces of land and Government considered that they should be given those lands in the Khas Mahal.

Mr. JAMUNA PRASAD SINGH: How many persons had applied for settlement of these lands?

The Hon'ble Mr. BADRI NATH VERMA : I want notice of the question.

Mr. JAMUNA PRASAD SINGH: On what grounds did Government consider that these lands should be settled with these persons?

The Hon ble Mr. BADRI NATH VERMA: That is a matter for Government to decide. Government thought that these lands should be ettled with the gentlemen in the interest of the town of Patna.

Mr. JAMUNA PRASAD SINGH: Will Government state the seasons?

The Mon'ble Mr. BADRI NATH VERMA: Government have already stated the reasons.

Mr. JAMUNA PRASAD SINGH: What are those reasons?

The Hon'ble Mr. BADRI NATH VERMA: In the interest of the town of Patna Government have settled these lands with these gentlemen.

Mr. MUHAMMAD NAUMAN: May I know whether it was in the public interest to settle these lands with the particular individuals?

The Hon'ble Mr. BARDI NATH VERMA: Government considered that it was desirable to settle the lands with these gentlemen.

Mr. MUHAMMAD NAUMAM: Had the public any information about the settlement of lands in Patna so that they could also apply?

The Hon'ble Mr. BADRI NATH VERMA: One can always apply.

Mr. SAIYID AMIN AHMAD: Did Government give an opportunity to others also (the gene al publi:) to apply for these lands?

The Hon'ble Mr. BADR; NATH VERMA: There was no question of a general land settlement.

Mr. SAIVID AMIN AHMAD: When lands have already been allot ed to these gentlemen why is the matter then under further consideration?

The Hon'ble Mr. BADRI NATH VERMA: There are many other things which have got to be settled, e.g., terms and rate of salami.

Mr. SAIYID AMIN AHMAD: There cannot be any question of terms being settled now as the settlement has already been made.

The Hon'ble the Speaker: In the answer given the word " allotted " has been used.

Mr. SAIYID AMIN AHMAD: Will the Hon'ble Minister state why no further communication has been made to the gentlemen concerned?

The Hcn'ble Mr. BADRI NATH VERMA: I have already aswered that point when I said that Government are considering the terms and conditions of settlement and the rate of salami to be paid and when Government come to a final decision on these points further communication will be sent to the gentlemen concerned.

Mr. SAIYID AMIN AHMAD: For how many months have the Government been considering these points?
