## THE BIHAR LEGISLATIVE ASSEMBLY DEBATES.

The 24th June, 1938.

Proceedings of the Bihar Legislative Assembly assembled under the provisions of the Government of India Act, 1935.

The Assembly met in the Assembly Chamber at Patna, on Friday, the 24th June, 1938, at 11-30 a.m., the Hon'ble the Speaker, Mr. Ram Dayalu Sinha, in the Chair.

The Hon'ble the SPEAKER: It is after a very long time that we see in our midst the Hon'ble Mr. Anugrah Narayan Sinha, our Finance Minister. ## ARREST OF BABU BALINDRA LAL DAS OF GAYA.

- 632. Mr. JAMUNA PRASHAD SINHA: With reference to the answer given on the 31st March, 1938, to a question put by Mr. Birendra Bahadur Sinha, will Government be pleased to state—
- (a) whether it is a fact that a copy of the report of the Subdivisional Officer was not supplied to Mr. Das although the enquiry held was styled a "judicial enquiry" by the Advocate-General on the last occasion; if so, why;
- (b) whether it is a fact that the enquiry was held in open court and witnesses were examined on oath and cross-examined by the lawyer engaged on behalf of the sub-inspector;

- (c) who paid the fee of Mr. Harihar Prashad, Advocate, and Babu Raghubir Prashad, Mukhtear, of the Gaya Bar, who had appeared during the enquiry on behalf of the sub-inspector, Babu Rambilas Roy;
- (d) if Government paid the fee of the above lawyers, whether it is done in all such cases, or this has been done as a special case, and if it has been done as a special case, why so;
- (e) if the fee had been paid by the sub-inspector concerned, whether he had taken the previous sanction of the Government for the purpose; if not, whether Government are prepared to take any steps in the matter?
- Mr. KRISHNA BALLABH SAHAY: (a) The report could not be supplied to him as it had already been sent to the District Magistrate. Mr. Das was told so by the Subdivisional Officer. No application to the District Magistrate was made by Mr. Das for a copy of the report.
  - (b) The answer is in the affirmative.
- (c) The Superintendent of Police reports that the sub-inspector engaged these lawyers and has paid them himself.
  - (d) Does not arise.
- (e) The sub-inspector was left to defend himself at his own expense and he was entitled to engage lawyers. Appendix 74 of the Police Manual governs this case and no previous sanction of Government was necessary.

POSTING OF KHAN SAHIB ABUL KHAIR, DEPUTY SUPERINTENDENT OF POLICE.

- 633. Mr. CHATURANAN DAS \*: Will Government be pleased to state—
- (a) whether it is a fact that Khan Sahib Abul Khair, at present the Deputy Superintendent of Police of Giridih, has been in the district of Hazaribagh continuously for more than ten years;
