Shri BIR CHANDRA PATEL: (a) To encourage the maximisation of sugar all over India a certain formula was laid down by the India Government according to which all sugar beyond the prescribed quantity of sugar was allowed for free sale by the sugar factories coming within the prescribed formula. This free market sugar is released by the India Government and the State Government has nothing to do with it. So far as the information of the State Government goes, free market sugar is reported to be selling in this State at the rate ranging between Rs. 60 to Rs. 65 per maund although some of the factories have quoted much lower rates of sales.

- (b) The answer is in the affirmative.
- (c) The State Government have no information on this matter.
- (d) Only the answer to clause (b) is in the affirmative and there has been no occasion for the State Government to write to India Government in this connection. The State Government are not aware if there is any discontent among the cane-growers on this score and if the production of cane is going to be affected by it.

Shri BIRCHANDRA PATEL: (a) The Assistant Farm Manager's post is a temporary one. As there is a shortage of quarters no quarters could be allotted to him.

DIFFICULTIES OF STUDENTS IN BIHAR VETERINARY COLLEGE.

- (a) whether it is a fact that the lectures in the Bihar Veterinary College are mostly comprised of dictation by the Professors and lecturers from the note-books to the students at a very high speed, which the students are unable to follow;
- (b) if the answer to clause (a) be in the affirmative, whether Government are aware of the fact that the students have to take down lectures in the College and have to write it down again at their residences in fair note books and this habit continues throughout the year with the result that they hardly get time for studies;
- (c) whether Government are aware of the fact that due to the above reasons the percentage of failure is high in all the classes of the Veterinary College;
- (d) in view of the above, whether Government propose to direct the professors of the Bihar Veterinary College to realise the difficulties of the students and dictate the lectures at a lower speed which may be within the reach of the students?

Shri BIRCHANDRA PATEL: (a) In some subjects no notes are dictated whereas in others notes are dictated in the interest of the students and simultaneously explained by the teachers. In no case the dictation is at such a speed that students cannot take the dictation down. The system of dictation is in vogue in all other technical colleges in India and abroad.
